For those that were not able to attend the annual meeting in Salina back in October, you missed a good one. I would encourage you to read through the minutes as we got a lot accomplished. One particular item that I'm excited about is that we gave the nod to Livia and her crew at K-State to give our website a makeover. It's no secret that we're in a technology-driven world and, as much as I've tried to fight it, the Internet has become THE WAY to communicate and disseminate information. Following the business meeting, we had an exceptional program on drought impact and mitigation. Our speakers from K-State and the National Drought Mitigation Center in Lincoln, NE provided some very valuable tools and resources for ranch planning. Again, KSSRM took the lead with this program and has since spawned several other drought meetings across the state held by other organizations.

It's hard to believe that 2011 is coming to a close. In light of this, don't think your duties are done. We still have elections to tend to. Please look through the bios in this Bluestem Bulletin and select those individuals that you want to lead us in the coming years. Your diligent voting in the past has positioned us well for the next couple of years with Jordge and Chris coming to the helm. We have a strong ballot this year and I believe all of the candidates are worthy of your vote.

In closing, I want to thank you again for this opportunity. It has been one great ride! I wish you all a very merry Christmas and I look forward to seeing you in Wichita on January 26 for our winter meeting.

October 27, 2011 Minutes of the Kansas Section of the Society for Range Management (SRM)

The Fall meeting of the Kansas Section for the SRM was called to order by president Cade Rensink @ K-State Salina. Cade then had everyone go around the room and introduce themselves. He then read several thank you notes that were received from those who attended the Ag Agents Tour that was sponsored in part by the Kansas Section.

Minutes from the previous meeting were reviewed via e-mail by the group. It was moved to accept the minutes, seconded, and the motion passed. Next was the treasurer's report read by Treasurer Alex Miller. The current balance is \$5312.62. Doug Spencer moved to accept the report as read, it was seconded and the motion passed.

Past president John Henry said he is in the process of setting up ballots for next year's officers. The ballots will be sent out by newsletter and must be returned by November 30th, 2011.

In other reports, Doug Spencer reported \$14,980.77 in the Range Youth Camp account.

President Rensink then reported on an initiative by the National SRM to recoup some of the membership lost in the past year. Some discussion followed on Kansas Section members who have not renewed their membership. Cade encouraged those in attendance to recruit people they knew interested in rangelands to join the Kansas Section.

The group then discussed awards nominations for the 'Trail Boss' and the 'Excellence in Grazing' awards. Cade said the committee is actively seeking nominations.

Livia Olsen discussed some possible changes that could be made to the Sections state website. She would like to update the site to make it more modern and accessible. She said she had a graphics designer interested in coming up with ideas. It was decided that the board would review the changes and approve the final design.

Walt Fick gave a report on the 2011 East and West adult range schools. He said that 33 participants attended the East school and 17 attended the west school. Discussion then followed about sponsoring 4 students who attended from the universities for a total of \$600 in scholarships.

Minutes Continued

Cade then discussed the proceedings of the National Advisory Council. They discussed revising the annual meeting handbook and posting the meeting minutes on the website for all members to view online.

Calvin Adams reported on the Ranch and Range Management Internship. He said they had three interns this summer that went to Ted Alexanders, Lynn Meyers (of Nebraska), and Ted Turner's Z-Bar ranch in Barber County. Calvin said that he is in the process of recruiting 5-6 interns for next summer. More information on this program can be found on the website ksranchinstitute.org.

Old Business

Doug Spencer reported on the potential of an annual Range Youth Camp Scholarship. Discussion followed. For several years the camp has had variable numbers of students attending range youth camp on an annual basis. In recent years, the camp fund has been used to reimburse college student registration fees to the annual SRM meeting. Due to the inconsistent registration income as well as the annual expense for registrations recently incurred, it was decided by the group to not pursue a college scholarship with the range youth camp account but to continue the support of the annual meeting registration fees.

Kevin Price reported on the SRM poster committee. Jorge Lafantasie said that she has someone interested in doing some original artwork for the Section. They would like some ideas for the artwork. Jessica Casey volunteered to help with the committee.

Carol Blocksome reported that the Oklahoma Section will not be needing any help with the 2013 Annual Convention in Oklahoma City.

Cade talked about the board of directors' decision to contribute \$1000 to KGLC for their grazing stick project. Tim Christian from the KGLC said that they appreciated the contribution. He said they had 9 contributors for a total of \$8800. He said the money went to create grazing sticks for the Tallgrass, Midgrass, Shortgrass, and Tame grasslands in Kansas.

New Business

President Rensink discussed the future of KSSRM annual meetings. According to the by-laws the group should give some opportunities for posters and presentations. Discussion followed on ways to incorporate this into the meeting.

Jorge L. said that she has some students who would like to attend this year's meeting in Spokane, Washington. In years past the group has reimbursed students for their registration fees. Fort Hays will likely have 4 undergrads and one graduate student attending. There is also a chance 2 or 3 K-State students will be attending the meetings. Keith Harmoney moved to offer scholarships to the SRM annual meeting with a cap of \$1000. The motion was seconded and passed by group vote. Registrations must be sent to Doug Spencer for reimbursement from the RYC account.

A motion was made to allow Livia Olsen the opportunity to make changes to the SRM website. The Board of Directors will review the website.

David Kraft made a motion to pay KGLC for \$600 for 4 scholarships for the 2011 Adult Range Schools. The motion was seconded and was passed by the group.

John Henry moved to transfer \$500 from the Range Youth Camp fund to the general fund to help cover the cost of the grazing sticks. The motion on the floor was then seconded and was passed by vote.

Cade then asked for a motion for adjournment. Doug Spencer made the motion, it was seconded by Calvin Adams, and the meeting was adjourned. The next meeting will be January 26th, 2012 at the Kansas Natural Resources Conference in Wichita.
